Tax Benefits of Year-End Giving



With the December 31 deadline for tax-deductible gifts in sight, now is the perfect time to think about making charitable gifts. Giving at the end of the year can be an opportunity to tithe from a work bonus, catch up on giving for the year, bless others, and benefit from attractive tax deductions. These gifts provide the opportunity for you to **make a difference in others lives, show generosity, and support a need within your church or community.**

Once you think of a charitable cause, determining what to give, and what makes the best type of gift, is the next step. You might want to consider one-time gifts, legacy gifts, and the tax ramifications for your gift. **Choosing a gift that best fits both your needs and the needs of the organization doesn't have to be difficult;** we have outlined some of the most popular ways to give, and their benefits, on page 3.

Ways to Give

A one-time gift of cash, stocks, bonds, real estate, or personal property can offer immediate tax deductions while charitable gift annuities offer deductions over a longer period.

Charitable gifts of stocks and bonds*, real estate, and personal property can be given at any time. When donating these gifts, an immediate tax deduction is available for the market value of the asset(s), which gives you the opportunity to see your gift working now to help the current needs of the church.

If you are looking to make a gift that will provide you with current or future revenue, you may want to consider a charitable gift annuity or charitable remainder unitrust. These types of gifts will provide you with revenue for life, and the remainder will transfer to the church at the time of your passing.

Plan a Successful Year-End Giving Campaign



Throughout the year the church raises funds for a variety of different ministries and outreaches. As fall begins, many churches start to plan and implement a strategy for one last giving campaign before the end of the year. **A year-end giving campaign can be a great way to encourage generosity** the last couple months of the year, and it can be a benefit to those looking for tax-deductible donations before tax season.

Typically churches focus on a single year-end giving campaign to support a need either within the church walls or in the community. With Thanksgiving and Christmas on the horizon, it is the perfect time to begin a giving campaign. **It can be a good reminder to examine and reflect on reasons we are generous, as well as look for opportunities to give, during a season marked by generosity.**

It's not too late to start promoting generosity this year. Follow these guidelines for a smooth and successful year-end giving campaign.

Step 1

Start with a clear goal. Brainstorm giving ideas with your team to determine what the campaign will support: a new building project, the children's ministry, an outreach ministry like the food pantry, a local homeless shelter, etc.

Step 2

Raise awareness for your campaign. Start sending emails and letters, posting on social media, making announcements during services, and planning generosity sermons that include the current need and how the congregation can help solve this issue. Be sure it is well known where people can go to give to this campaign.

Step 3

Be consistent with your messaging. Throughout November and December, be sure you are delivering consistent information and announcements about your campaign. Share stories from people who are already giving, how to give, ways people can get involved, the lives that will be changed and impacted if you reach your goal, and how your leadership is involved in giving.

Step 4

After the campaign is over, don't miss the opportunity to thank your donors and celebrate your success, even if you didn't reach your goal. Remind the congregation how their gifts will impact the church or community, and when they can expect to start seeing results. During the next couple of weeks after its conclusion, keep the church updated with the campaign.

Outright Gift

- Quick and simple gift
- Donate cash, securities, or personal property
- Income tax deduction and avoid capital gains tax

Bequest in a Will

- Give after your lifetime
- Name your church in your will
- Federal estate tax donation exemption

Charitable Gift Annuity

- Contract to give after your lifetime and receive annual fixed payments now
- Current and future tax exemptions

Donor Advised Fund

- Flexible and allows your input on how funds are used
- Foundation manages assets, and you suggest beneficiaries
- Immediate income tax deduction

Retained Life Estate

- Give a personal residence or farm to your church but continue occupancy for your lifetime
- Charitable income tax deduction
